NSKFDC, invites sealed Request for Proposal (RFP) from Government bodies, Central and State PSUs, other autonomous bodies, Private Companies, Real Estate Developers and individuals who are legal owners of approved properties or their authorized agent/agencies for outright purchase of office space measuring 8,000 to 10,000 Sq. Ft covered area situated in Delhi.

REQUEST FOR PROPOSAL FOR PURCHASE OF OFFICE SPACE/PROPERTY FOR NSKFDC IN DELHI

NSKFDC is a Government of India Undertaking under the aegis of Ministry of Social Justice & Empowerment. The Corporation was incorporated on 24th January, 1997 under Section 25 of the erstwhile Companies Act, 1956 (now Section 8 of the Companies Act, 2013) as a Company 'Not for Profit' with the primary objective of socio-economic development of Safai Karamcharis, Manual Scavengers, Sewer and Septic Tanks Workers, Waste Pickers and their dependants through its loan and non loan based schemes.

NSKFDC invites offers in two bid systems from Government bodies, Central and State PSUs, other autonomous bodies, Private Companies, Real Estate Developers and individuals who are legal owners of approved properties or their authorized agent/agency for outright purchase of office space in Delhi. The offers should be neatly typed submitted in a sealed envelope super-scribing "OFFICE SPACE/PROPERTY FOR SALE IN DELHI" latest by 11.00 A.M on 13.10.2025 at the Corporate office address of NSKFDC in person or by hand/speed post/courier.

The property owner(s) are advised to go through the following details and terms and conditions:-

- i. The property should be free from encumbrances, legally compliant, and suitable for official use/commercial purposes.
- ii. Freehold office Space measuring between **8,000 to 10,000 square foot Covered area**, situated in Delhi. The rates of the property will be calculated based on the super area of the property. The Required area is tentative and can be increased or decreased at the time of finalization.
- iii. The property/building should not be more than 20 years old.
- iv. Preference will be given to properties in close proximity of Shastri Bhawan, Central Secretariat and CGO Complex, Lodhi Road. Properties falling within 15 km radius of Shastri Bhawan as well as CGO Complex, Lodhi Road, New Delhi only shall be considered.
- v. NSKFDC may consider individual proposal as well as proposals involving two contiguous/non-contiguous properties owned by different legal owners (companies/LLP/Partnership/individuals etc.), subject to the following conditions:
 - Both properties must be located on the same floor of the same building.
 - The combined built-up area must meet the minimum space requirement specified in the tender.
 - The proposals from both owners must be submitted jointly or jointly through an authorized agency/agent or through a third party intermediary
- vi. The whole office space/property should be located on the same floor.
- vii. Since the target group of NSKFDC belongs to most downtrodden section of the society, the property should be easily approachable for them. Nearest Metro Station or Bus Stop should be within 1 Kilometer.
- viii. Offered premises should be Semi/fully furnished and should be in ready to move in ready condition.

Semi-Furnished Office Space means Complete civil works, flooring, false ceiling, electrical wiring, lighting, basic HVAC provisions, and sanitary fittings; ready for furnishing and modular customization as per requirement.

Fully-Furnished Office Space means Complete interiors including modular workstations, cabins, conference rooms, reception, storage units, network cabling,

HVAC systems, and all essential furniture and fixtures, enabling immediate occupancy and operations.

- ix. Offered premises and surroundings should be in good condition and well maintained with roads near the entry and exit points free of traffic congestion.
- x. Premise Security System–Extensive coverage of CCTVs for all common areas.
- xi. Accessible for Handicapped persons as per Govt. Guidelines.
- xii. Availability of Parking Space for 20 Cars.(minimum10 & preferably20)

INSTRUCTIONS:

- i. Interested parties i.e. property/space owners or their authorized agencies, possessing office space area as stated above, having clear legal title are invited to send their proposals to our registered office in the prescribed template enclosed herewith furnishing details like name of the owner and authorized agent/agency, contact details, location of the office space, space details, amenities, etc. No brokerage will be paid by NSKFDC.
- ii. On receipt of such proposals, the said premises will be inspected for evaluation and preliminary short-listing by NSKFDC Committee. The proposals can be submitted by the authorized agency. The authorized agency will have to enclose the letter of authority from owner along with their offer. The Proposal should be submitted to NSKFDC address given below, on/before The Proposal should be complete in all respects and signed on all pages. The Proposal should be delivered in a sealed envelope mentioning "OFFICE SPACE/PROPERTY FOR SALE IN DELHI" having two separate sealed envelopes inside (Technical Bid and Financial Bid).

iv. EMD and Tender Fee

EMD: Rs. 2,00,000/- (Rs. Two Lakh only) in the form of Demand Draft, from any of the Scheduled Bank drawn in favour of National Safai Karamcharis Finance and Development Corporation payable at New Delhi.

Tender Fee: Tender Fee including GST of **Rs. 1,000/- (Rs. One Thousand only)** will be charged, which is to be submitted along with the Technical Bid in the form of Demand Draft, from any of the Scheduled Bank drawn in favour of National Safai Karamcharis Finance and Development Corporation payable at New Delhi.

The MSME agency/units shall be exempted from submission of EMD or tender fee as applicable on production of proof of current registration certification from MSME/NSIC

for the tendered item. Please note that the tender without accompanying the requisite EMD shall not be evaluated and shall be summarily rejected. EMD of unsuccessful bidders shall be refunded immediately after selection of the successful bidders.

- v. Late submissions of applications (received after due date and time of submission of document) shall not be accepted under any circumstances.
- vi. NSKFDC reserves the right to accept or reject any or all Proposals/applications without assigning any reasons. No applicant shall have any cause of action or claim against NSKFDC for rejection of its/their Proposal/application.
- vii. Notwithstanding anything contained above, NSKFDC reserves the right to reject any or all Proposals/offers and may also give consideration to properties other than those offered in response to this advertisement.
- viii. NSKFDC reserves the right to cancel the entire RFP process at any stage without assigning any reasons.
- ix. Applicant must not have been black listed or deregistered by any central/state government department or public sector undertaking. The applicant should have to submit undertaking to this effect in the prescribed format as per **Annexure-1**.

x. CORRUPT OR FRAUDULENT PRACTICES

NSKFDC requires that the applicants under this process observe the highest standard of ethics. In pursuance of this policy, NSKFDC defines, for the purpose of these provisions, the terms set forth as follow:

- i. "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
- ii. "Fraudulent practice" means concealment and/or misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of NSKFDC, and includes collusive practice among Applicants (prior to or after submission of application) designed to establish bid prices at artificial non-competitive levels and to deprive NSKFDC of the benefits of free and open competition.
- (a) Will reject a proposal if it determines that the applicant has engaged in corrupt or fraudulent practices in competing for the tender.
- (b) Will declare an applicant ineligible either indefinitely or for a stated period of time, if it at any time determines that the applicant has engaged in corrupt or fraudulent practices in competing for or in executing the tender.

An Applicant shall submit an undertaking in this regard in the prescribed format as per Annexure-2.

- xi. Applicant must not have suffered bankruptcy/insolvency during the last three years. The applicant should have to submit undertaking to this effect in the prescribed format as per **Annexure-3.**
