1	Which portal will be used to register the waste pickers, PM Daksh or SIDH (Skill India Digital Hub)?	SIDH (Skill India Digital Hub) portal will be used to register the waste pickers.
2	How will the assessment of the waste pickers be done after the completion of training?	The assessment will be done by the Govt. recognised assessment bodies as per MSDE norms.
3	Under Section 18. Average Unit Cost and Assumptions, Accidental Insurance for whom has to be done?	The accidental insurance of one year for waste pickers is included in the Average Unit Cost.
4	Is the average unit cost based on per trainee?	Yes
5	Is there any option for including school premises as training centres?	Yes, school premises with required facilities may be opted as a training centre but the same will fall under the category of Industry Premises for costing norms.
		Further, any training centre other than accredited & affiliated training centre will be considered under the Industry Premises for costing norms.
6	What will be the format for assessment of the waste pickers?	The detailed assessment strategy will be shared separately.
7	Are the training centres to be enrolled in SIDH Portal?	Yes.
8	What will be the compensation for loss of livelihood during the training programme?	The stipend of Rs 1000 is payable through DBT (Direct Benefit Transfer) to the waste picker subject to minimum 80% attendance.
9	Will the training partners be allocated at ULB or District level?	It depends on the number of successful proposals received for a particular location.
10	What will be the minimum number of on-site visits and what should be the distance of these visits?	Training partners need to ensure that the on-site visits are planned as per the requirement of training modules

		within the proximity of training location.
11	What will be supporting Documents for Technical Proposals (ANNEXURE - 7) of the RFP?	The Organisations need to provide supporting documents which substantiate organisations credentials and past experience such as project completion report, letter of award, evaluation study report, client certificate, etc.
12	What will be the evidence supporting TPs Needs to submit for the proposed locations and geographical presence (ANNEXURE 7 & 8) of them?	The Organisations need to provide MoUs, Contracts, Letter of awards, evaluation study reports, Letter from Client, proof of the training projects or similar documents.
13	Under section 6.2 sl. No. 5 of the technical evaluation, how many past Year experiences will be considered? Regarding the "Number of sanitation workers/waste pickers trained more than 500 persons," could you specify the relevant year?	Experience during the last 07 financial years i.e. from FY 2018-19 to as on date/ ongoing will be considered for this purpose.
14	Under section 6.2 sl. No. 2 Regarding the "Total number of persons trained, who have also been certified by government-recognized bodies," could you specify if this requirement applies to any category (e.g., 5000 candidates) or specifically to waste pickers?	This is the number of persons trained in all categories and not specific to Waste Pickers. The question no. 4 in page number 12 specifically relates to the number of Sanitation Workers/ Waste Pickers trained.
15	When does EMD need to be submitted?	EMD to be submitted with the proposals as mentioned in the RFP
16	Who will certify the training?	Certification will be done as per MSDE norms.
17	If multiple partners are providing Training, what will be the marking criteria for them?	The marking for them will be done in a cumulative manner and the combined experience of the JV would be considered for this purpose.
18	We are intending to form a JV to participate in the said RFP and the lead company is registered with MSME. Will the tender Fee and EMD be exempted for the lead company (under JV) that is registered with MSME?	The exemption will depend on whether the JV is registered with MSME and eligible for exemption.
19	Under section 6.1 (point 12) "Have all the pages	Yes

	required to be signed by the authorized representative of the applicant being signed?" Does it mean that all required pages must be signed by our authorized representative?	
20	Could you please explain the term "Details of Waiver/Flexibility" and whom is it applicable for in Annexure-2?	Any specific waiver/flexibility required by the applicant for implementing the Occupational Safety and Skill Upgradation Training of Waste Pickers programme may be mentioned. However, waiver/ flexibility may or may not be considered.
