- 2. The cost would be including all taxes.
- 3. The work will be allotted on overall lowest rates basis.
- 4. Rates must be filled in the format only otherwise tender will not be considered.
- 5. Where cost has been mentioned as "As per actual" the cost would be considered already included. No payment will be made for that service although the party has to provide those services on their own cost. No payment will be made by the Corporation.
- 6. Rates, wherever required, may be quoted for all fourteen days.
- 7. All the pages of document should be signed by the bidder or its authorized person with Seal.
- 8. Any other terms & conditions written or printed on the Quotation/tender document by the bidder, or otherwise sent along with tender, will not be accepted and will not binding.
- 9. The bids should be typed only, hand written, Incomplete bids will be summarily **Rejected** without giving any reason what so ever.

- 13. Rates should be inclusive of all taxes. No revision of rates shall be allowed under any circumstances whatsoever.
- 14. The company required to fill the Technical details mentioned at <u>Annexure-A</u> and the attested copies of the supporting documents should be attached with the quotation.
- 15. The successful bidders who have been awarded the work shall liable to pay penalty for any omission(s) during the exhibition.
