This is to invite Proposals from Central/State/UT/Government Bodies/Public and Private Sector Companies/Institutes/not-for-profit body registered under any of the Central/State/UT statues, a firm/corporation duly registered, as partner agencies for facilitating eKYC of ingested beneficiaries PAN INDIA of NAMASTE in Beneficiary identification System of NHA, collection of additional information of family members and subsequent distribution Camps of cards.

1. BACKGROUND

National Safai Karamcharis Finance & Development Corporation(NSKFDC), a wholly owned Govt. of India Undertaking under the Ministry of Social Justice & Empowerment (M/o SJ&E) was set up on 24th January 1997 as a Company "Not for Profit" under Section 25 of the Companies Act, 1956. NSKFDC is in operation since October, 1997, as an Apex Corporation for the all round socio-economic upliftment of the Safai Karamcharis, Scavengers and their dependants throughout India, through various loan and non-loan based schemes.

National Action for Mechanized Sanitation Ecosystem (NAMASTE) is a central sector scheme that is going to be jointly implemented by the Ministry of Social Justice & Empowerment (MoSJE) and the Ministry of Housing & Urban Affairs (MOHUA).

The implementing agency for the scheme is National Safai Karamcharis Finance & Development Corporation Limited (NSKFDC). The NAMASTE scheme is implemented across all Urban Local Bodies (ULBs) (all Cities and Towns, including Cantonment Board (Civilian areas)).

One of the components of the scheme is

Health Insurance coverage of NAMASTE identified beneficiaries under PM-JAY: To provide safety
nets to workers and their families in case they fall sick or meet with an accident; each
beneficiary will be covered under the Ayushman Bharat- Pradhan Mantri Jan ArogyaYojana (ABPMJAY), and premium for those beneficiaries who are not covered earlier shall be borne by
MoSJE under NAMASTE after verification to avoid duplication.

This tender issued aims to identify suitable partner Institutes/Agencies to facilitate eKYC of ingested beneficiaries PAN INDIA of NAMASTE in Beneficiary identification System of NHA, collection of additional information of family members and subsequent distribution Camps of cards. 2. Eligibility Criteria for Applying

- i. The Agencies/Institutes must have been in existence of more than 3 years and could be a Central/State/UT/Government Bodies/Public and Private Sector Companies or Institute/ not-for-profit body registered under any of the Central/State/UT statutes; a firm/corporation duly registered.
- ii. The Agencies/Institutes accounts should have a positive net-worth & should be profitable and last three year of audited accounts upto financial year 2023-24, by a firm of Chartered Accountants.
- iii. The Agencies/Institutes Should have at least 3 years' experience in organizing large-scale community registration or welfare programs and have previous work with marginalized communities.
- iv. Agencies/Institutes should not have been blacklisted by any Government Agency or department/ PSU/Corporate.
- v. Agencies/Institutes should not have any legal matter/dispute pending in any court of India regarding mismanagement of funds etc.

3. Scope of Work

The empanelled Institutes/Agencies should organize camps for facilitating eKYC, collection/rectification of any incorrect information of family members and distribution Camps for providing Health Insurance (Ayushman Card) to beneficiaries (Sewer and Septic tank Workers, Waste Pickers, Manual Scavengers) which may include the following tasks; -

- i. **Planning and Organizing Camps:** Identify suitable locations for the camps in consultation with concerned Urban Local Body. Arranging necessary equipment, and ensuring accessibility.
- ii. **Community Mobilization and Awareness:** Coordinating with ULBs, PMUs for informing the beneficiaries about camp and about the benefits of Ayushman Cards.
- iii. **eKYC:** To Facilitate the eKYC process on NHA BIS.
- iv. **Family Members data Completion :** To add information on portal for family members (wherever necessary) of ingested beneficiaries.

v. **Distribution/Delivery of Ayushman Cards:** Distribution post printing on PVC of the downloaded cards.

5. SelectionCriteria

The Agencies/Institutes will be selected based on Quality and Cost Based Selection- QCBS (Technical: Financial): 70:30.

- i. Bidder having less than **40 marks** in aggregate (from Sr. No.1 to 3) will be rejected and will not becalled for Technical Presentation.
- ii. In order to qualify for financial evaluation, the bidder must have at least (70 Marks out of 100) fromSl. No. 1 to 4 in the technical evaluation carried out on the basis of above-mentioned criteria.
- iii. The consulting organization will be selected based on QCBS as per weightage (Technical: Financial) = **70:30.** i.e. ratio of 70:30 is to be maintained between Technical and Financial scores to arrive at the overall score.
- iv. Submission of technical presentation is mandatory.

6. Clarification of Bids

- i. To assist in the examination, evaluation, comparison, and qualification of the bids, the bid evaluation committee of NSKFDC may, at its discretion, ask any Institutes/Agencies for clarification regarding their bid.
- ii. Bidders shall submit their queries related to the Tender by email on or before 07.03.2024, 03:00 PM to the following email address: nskfdc-msje@nic.in.

7. Financial Bid Evaluation

The Financial bids of only those bidders who qualify in the technical evaluation will be opened. All other Financial bids will not be opened.

8. Final Bid Evaluation based on Quality & Cost Based Selection(QCBS)

- i. Bidder with the highest final composite score will be called for awarding the contract.
- ii. In case of a tie in the final composite score, the bidder with the higher Technical Score will be invited for awarding the contract and selection first.
- iii. The work/job may be assigned to different parties in different States at discretion of NSKFDC provided rates are matched to quote of bidder with highest final composite score.

9. TenderFee and EMD

A demand draft of Rs. 1,000/- towards tender fee from any commercial bank drawn in favor of "National Safai Karamcharis Finance and Development Corporation", payable at New Delhi shall be submitted along with the bid and it is non-refundable.

The intending bidders should pay along with bids an Earnest Money Deposit of Rs. 40,000/- The EMD shall be paid by Demand Draft drawn from any scheduled commercial bank in favour of "NSKFDC" payable at New Delhi. The EMD will not carry any interest.

The EMD submitted by the bidder will be forfeited if:

- The bidder withdraws or amends its tender or derogates from the tender in any respect within the period of validity of its tender. Further, if successful bidder fails to accept the LOA
- The bidder withdraws his bid after processing but before acceptance of award of contract issued by NSKFDC
- The bidder violates any of the provisions of the terms and conditions of the tender specifications
- Final decision on EMD forfeiture will rest with the Competent Authority of NSKFDC

The EMD will be refunded to:

- The successful bidder, after successful completion of the implementation period (6 months).
- The unsuccessful bidders, only after acceptance of award of contract by the selected bidder or in case of cancellation of Tender
- The Earnest Money Deposit (EMD) will be refunded without any interest under all conditions.

Offers received without EMD will be summarily rejected

The bidders registered with MSME /NSIC are exempt from payment of tender fee and EMD if they produce a valid certificate.

10. Performance Bank Guarantee

- i. The successful bidder will require to submit a Performance Bank Guarantee issued by any scheduled commercial bank for 10% of the contract value valid for entire duration of the contract.
- ii. The Bank Guarantee may be invoked by NSKFDC in case of failure of vendor to adhere to the terms & conditions of the contract.

iii. In case of delays in execution of project, NSKFDC may seek extension of the PerformanceBank Guarantee for commons rate period which will require to be acceded to by the vendor.

11. PaymentTerms&Schedule

- i. It will be mandatory for the bidder to indicate their bank account number and other relevant E-payment details so that e-payments could be made.
- ii. The payment will be made as per the following terms, on production of the requisite documents.
- iii. All deductions on account of incometax as perprevailinglaw shall be madefrom the payment being made and such deducted taxes shall be remitted to the concerned tax department.
- iv. All Payments to be made in INR only and subject to liquidated damages and taxes, duties, penalties as applicable, if any.
- v. No advance payment will be given to the agency for eKYC, distribution of Ayushman card.

Paymentschedule:

100% service charge based on number of Ayushman Card distributed to beneficiary target group under NAMASTE will be released to Service provider upon submission of documentary proof along with claim for the same.

12. Indemnity

Institutions / Agencies should agree to defend, indemnify, keep indemnified and hold harmless, NSKFDC, against all and any claims, loss, damage, demands or cost including but not limited to taxes/duties damages, expenses, penalties, liabilities, legal cost and any claims of whatever nature, arising from but not limited to any action, omission, willful conduct, negligence and/or breach of any term or condition under this tender. Institutions / Agencies shall always abide by the laws of the State and Central Government as applicable/in force from time to time. NSKFDC shall not be responsible for any repercussion on this tenderon account of any change in Government Acts, Rules and Regulation, or for any failure on the part of the IA.

13. Arbitration

In case, a dispute or difference arises, between the parties about the terms and conditions of this agreementor pertaining to any other dispute relating to this agreement, and if both the parties to the dispute fail to get the dispute settled themselves, then any of the parties shall have a right to get the dispute settled under the Arbitration and Conciliation Act, 1996, including any statutory modifications, amendments, re-enactments thereof from time to time by reference to a sole arbitrator, to be appointed by the Managing Director of NSKFDC to decide the disputed matter. The award of the Arbitrator shall be final and binding on both the parties. Such arbitration shall be conducted in English language. Arbitration proceedings will be conducted in New Delhi. The fees and other incidental expenses incurred by the Arbitrator for conducting proceedings shall be borne by both the parties in equal share.

14. ForceMajeure

If at any time, during the continuance of the contract, the performance in whole or in part by either party

of any obligation under the contract is prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, acts of God (hereinafter referred to as "events"), neither party shall, by reason of such event, be entitled to terminate the contract, nor shall either party have any claim for damages against the other in respect of such non-performance or delay, provided the performance and/or delivery is resumed as soon as practicable after such event has come to an end or ceased to exist. The decision of NSKFDC as to whether the performance or deliveryhas so resumed or not, shall be final and conclusive, provided further, that if the performancein wholeorin part oranyobligationunderthecontract is prevented or delayed by reason of any such event for a period exceeding 30 days, the NSKFDC may at its option, terminate the contract without any obligation to compensate.

15. Terms and Conditions

- i. The Institutions/Agencies should apply only if they are willing to work in any States/UTs of PAN INDIA.
- ii. The Institutions/Agencies must submit the Tender Fee as mentioned in clause no.9.
- iii. The service charge shall be payable to the empanelled Institutions /Agencies based on the number of Ayushman Cards distributed to beneficiaries with proper supporting documents as proof of claim.
- iv. The Bidders will agree to match with the lower quote in case of different bids in different State.

 The work/job may be assigned to different parties in different States.
- v. The date, time and venue of each camp will be intimated in advance to NSKFDC. However the agency may undertake ward wise approach or any other feasible approach.
- vi. It shall be the empanelled institution's/Agencies responsibility to make all physical/other arrangements tentage etc. at your cost including giving adequate publicity in nearby areas of the camps and obtaining approval of the local authorities for organizing camps, if any is required.
- vii. Any liability/claims arising due to the organizing of camps shall be that of the empanelled institution/Agencies. It will be the sole responsibility of the institution/agency if any hurdles/losses occur while organizing the camps.
- viii. The Defect Liability Period shall be for a period of one year from the date of completion of the work. During this period, the vendor will be responsible to rectify any defect without incurring any additional cost.
- ix. Service Legal Agreement shall be entered with the service provider duly incorporating scope ofwork, roles and responsibilities of parties, conflict resolution mechanism, timeline of contract etc.
- x. Empanelled Institutions/Agencies will comply with other terms and conditions as per the Letter of Intent (LOI) to be issued by NSKFDC & such other terms as may be specified therein. NSKFDC may at its discretion assign work and venues to any one or more of the empanelled institution(s), depending upon its requirement, subject to fund availability.
- xi. In case the selected Bidder fails to reconfirm its commitment and is unable to start the process of registration of Health Insurance within one month after the sanction of Letter of Intent, the NSKFDC reserves the right to terminate Work order and designate the next ranked Bidder as the Selected Bidder and invite him foraward of contract.

xii. Period of empanelment: The empanelment for this work order will be valid for a period of 6 months w.e.f. the date of your acceptance of the Letter of Intent. NSKFDC reserves the right to cancel the empanelment of the institution/agencies at any time.

16. Submission & Evaluation of BIDS:

- i. The Bidders have to submit a TenderFee.
- ii. The Technical Bid as per Annexure-I with all relevant supporting documents along with tender fee) & Financial Bid as per Annexure-II) for service charges for the Verification, Authentication, Registration and Distribution Camp for (Ayushman Card) needs to be submitted in two separate envelopes duly superscribed as "Technical Bid" & "PRICE BID" of this bid document. Price bids shall open for those agencies who have qualified after technical evaluation.
- iii. The entire set of documents is required to be sent by post to Manager (NAMASTE), NationalSafai Karamcharis Finance & Development Corporation, NSKFDC, NTSC, 3rd Floor, E-Block, NSIC, Okhla Industrial Estate III, New Delhi 110020 on or before 21.03.2025 (6.00 PM) or can be dropped in the tender box available in the office premises during working days (9.30 am to 6.00 pm.)
- iv. NSKFDC reserves the right to amend, modify and change the terms and conditions of empanelment as deemed necessary.
- v. Please note that the Empanelment process can be cancelled by the National Safai Karamcharis Finance & Development Corporation (NSKFDC) on its discretion.
- vi. Validity: The bid should be valid for 90 days from the date of opening of the financial bid.
